## News

### CONTRIBUTIONS SOUGHT FOR THE REVIEW OF THE BIG LOTTERY FUND – CALL FOR EVIDENCE

The Government is seeking views on the functions, form, effectiveness, efficiency and governance of the Big Lottery Fund.

The Triennial Review of the Big Lottery Fund is being conducted as part of the requirement for all Government Departments to review their Non Departmental Public Bodies (NDPBs) at least once every three years.

The review team will examine whether there is a continuing need for the functions performed by the Big Lottery Fund, and whether the organisation should continue to operate in its current form.

An assessment of whether the Fund's control and governance arrangements continue to meet the recognised principles of good corporate governance will be conducted if it is decided there is a need for the organisation in its current form.

In order to make a full assessment, the review will take into account the views of people who have an involvement with, or interest in, the Fund.

### COMMUNITY TRANSPORT VEHICLE FUND

This scheme is a one-off Scottish Government initiative with £1 million available for 2013/14 which is jointly managed by the Scottish Council for Voluntary Organisations (SCVO) and the Community Transport Association (CTA). It aims to help community transport operators buy new vehicles either to replace older vehicles or to expand services.

This initiative has arisen because the Scottish Government recognises that funding of vehicles is a particular problem for community transport operators and also because community transport meets a number of social objectives, such as:

- Giving older and disabled people who cannot use mainstream transport mobility and access to services.

- Providing access to health and social care services.
- Helping to build more resilient communities by ensuring that people are not isolated.

The Scottish Government wishes to provide this support to organisations whose transport services are likely to have the biggest impact in their communities. It is anticipated that most of the fund will be used to replace vehicles which are now close to the end of their useful life and are well used in their local communities. However, vehicles for new services will also be considered, applications will need to be exceptional and show a strong case for the need for the vehicle and the impact it would make on lives and communities.

## COASTAL COMMUNITIES FUND (CCF) PROGRAMME – THIRD ROUND

The Coastal Communities Fund (CCF) will encourage the economic development of UK coastal communities by giving them funding to create sustainable economic growth and jobs. The Big Lottery Fund is delivering the CCF on behalf of Government.

Grants of £50,000 and over are available. The following types of organisation can apply:

- local authorities
- regeneration agencies in Scotland, Wales and Northern Ireland
- other public sector bodies
- charities
- voluntary and community sector organisations
- social enterprises, including cooperatives and community ownership initiatives
- private sector companies.

For CCF round three, as different from previous years, **we are looking for fully developed projects that can spend their CCF award before the programme closes in March 2016.** It is important for potential applicants to be aware of this requirement.

**The programme will open for applications from projects in January 2014 and will close for stage one applications on 24 March for Scotland and Northern Ireland**

# New Funding Opportunities

## Arts, Culture & Heritage

### THE RADCLIFFE TRUST

This scheme, established in 1714 as a charitable trust, makes grants to registered charities within the UK principally in two sectors: music, heritage, and crafts.

#### 1. Music Grants

The trust supports classical music performance and training especially chamber music, composition and music education. Particular interests within music education are music for children and adults with special needs, youth orchestras and projects at secondary and higher levels, including academic research.

Applications are considered under the following headings:

- Composition and contemporary music.
- Bursaries for courses and summer schools for UK based students.
- Music therapy/special needs.
- Academic research/projects.
- Youth orchestras.
- Performance projects.
- Educational projects.
- Miscellaneous.

#### 2. Heritage & Crafts Grants

The trust supports the development of the skills, knowledge and experience that underpin the UK's traditional cultural heritage and crafts sectors. This includes support for craft and conservation training, for practical projects, particularly those that include a strong training element, and for strategic and capacity building projects which demonstrate clear benefits to the sector. However, the Trust will consider other projects, should they fall broadly within its remit. The Trust wishes to promote standards of excellence through all its support.

Applicants are advised to submit an application well in advance of the following deadlines:

- **Annual Music deadlines: 31 January and 31 August.**

## Business & Enterprise Development

### DG ENTERPRISE AND INDUSTRY

This scheme seeks to support proposals for projects to create an environment in Europe that encourages more web entrepreneurs to start a business and scale it up.

The focus will be on entrepreneurs who use web and mobile technologies as main components in their innovation. The Call is divided into two areas of focus:

1. Accelerate web entrepreneurship in Europe – this aims to attract proposals to develop and test online platforms connecting existing local web entrepreneurship ecosystems and hubs, and build upon these in order to provide new services for web entrepreneurs, complemented with other relevant activities.
2. Co-ordination activities in the area of web entrepreneurs – this aims to support actions across existing stakeholder communities. The aim is to increase the impact, accessibility and reach of the online support platforms and the new services they offer as well as link into other relevant initiatives.

It is anticipated that €10 million will be available.

## Children/Young People/Youths

### ERNEST COOK TRUST

This scheme targets registered charities that work with children and young people. All applicant organisations should be either schools, registered charities or other recognised not-for-profit organisations that would like to undertake projects which meet the Trusts' objectives and require a small amount of pump-priming in order for such projects to take place.

The small grants programme is for awards under £4,000 with an average award in the region of £2,000-£2,500 and grants are usually awarded for one year only.

### HENRY SMITH CHARITY: HOLIDAY GRANTS FOR CHILDREN

This scheme will soon begin accepting applications for holiday grants for children in 2014.

The purpose of the programme is to provide children aged 13 and under from disadvantaged backgrounds with a recreational holiday or outing they would not otherwise have the opportunity to access.

Please note that grants are available throughout the UK for holidays in the UK and range between £500 and £2500.

### SEAFARERS CHILDREN'S SUPPORT

This scheme provides help for Seafarers children who are in full-time education and their families are in severe financial difficulties.

The majority of the families they support are single parents. However they do support two parent families where one of the parents is too ill or disabled to work and the other acts as the carer.

The society currently supports over 450 children but is hoping to expand their outreach with the help of local community groups and fellow maritime charities. Grants from the Sailors' Children's Society can be accessed by single parent families on means-tested benefits, while two parent families must also be in receipt of DLA or equivalent to qualify for funding. In recent years, the charity has reported a rise in the number of grandparents requiring financial aid as grown-up children return home with families of their own to support. Without the backing of the charity, many older people would struggle to cope with the emotional and economic strain that caring for young children can put on a household

Based in Hull, the charity operates throughout Britain and has recently assigned Community Engagement Officers in Birmingham, Dover and Glasgow to extend their reach across these cities and

beyond.

Theresa McGuire, newly appointed Community Engagement Officer in Glasgow, said: "My role is to raise awareness of the support available from maritime charities. So many families don't know of the services we can provide for them if they have a nautical connection. It's my job to ensure that all other agencies offering support to families in Scotland know about our work and ask the right questions of their patrons to find out where our help can be given.

"There are grants to provide for children, or to fund holidays or computers, and we work with a variety of different organisations to maximise the number of people we can reach out to. We know how hard it can be for these families to sustain even a simple lifestyle, and a little support – whether financial or emotional – can be all people need to set them back on the right path."

Theresa is keen to make sure that the available support is accessed by those who need it most.

"The organisation does fantastic work with some of the most underprivileged families," she explained, "but we can only reach the people that we know about. If you, or anyone you know, could benefit from the support that we offer, get in touch. It might mean the difference between sink and swim for a family in need."

## Disabilities

### BRUCE WAKE CHARITABLE TRUST

This scheme provides grants for the provision of leisure activities for the disabled in the UK.

The trustees will consider grant applications related to the provision of leisure activities for the disabled but favour particularly applications whereby the potential beneficiaries meet one or all of the following criteria:

1. The potential beneficiaries are physically disabled wheelchair users;
2. Improved access for wheelchair users is proposed; and/or
3. A sporting or leisure activity involving disabled wheelchair users is proposed.

Applications meeting the above criteria will be considered from

charitable organisations. Applications on behalf of individuals will only be accepted through a charitable organisation or equivalent recognised body.

All applications should be submitted together with appropriate financial information. Charitable organisations should include a copy of their latest financial statements.

## Education

### THE OGDEN TRUST

This scheme offers educational bursaries and grant programmes to maximise the opportunities available to young people in all parts of the UK's educational system and is now focused on science, particularly physics.

The trust will support educational costs for sixth form scholarships up to £8,000 per annum and Undergraduate Science Scholarships of up to £1,500 per annum.

However it is essential that 50% match funding is provided, preferably with an external sponsor. Schools are required to make a visit to a candidate's home before an Ogden award is made, and give the Trust a written report of that visit.

Individual science students and/or universities are eligible to apply.

### QUEEN ELIZABETH SCHOLARSHIP TRUST

Covering a wide range of modern and traditional crafts, the Queen Elizabeth Scholarships are worth between £1,000 and £18,000.

The scholarships can be used to fund further study, training and practical experience for the improvement of craft and trade skills.

Eligible applicants are craftsmen and craftswomen of all ages who live and work permanently in the UK. Applicants must be able to demonstrate that they already have a high level of skill and are firmly committed to their craft or trade.

Previous scholarship winners have included antiques restorers, calligraphers, book conservators, potters, silversmiths and upholsterers.

## Entrepreneurs

### THE STARTER FOR 6 MAIN PROGRAMME – 2014 ROUND

This scheme is now open to applications for its 2014 round, an enterprise training programme that supports up-and-coming creative entrepreneurs across Scotland. It aims to turn creative ideas into successful businesses, thereby contributing towards the success of the Scottish economy and raising the awareness and profile of talented entrepreneurs throughout the country.

The programme is weighted towards business ideas that come from across the creative industry sectors and that are genuinely pushing business boundaries in terms of creativity, innovation, design, new markets and product developments.

Applications are welcomed from Scottish entrepreneurs over 16 years of age, who can put forward a new idea, product, service or experience that does not already exist, or at least an innovative spin on anything that does already exist.

Support provided to successful applicants includes enterprise training sessions, peer mentoring from previous Starter for 6 participants, telephone coaching support, the opportunity to network and share ideas with like-minded entrepreneurs in training sessions and events and the opportunity to pitch for up to a maximum of £10,000 of grant funding at the end of the training programme.

### PATHS FOR ALL (SCOTLAND)

This scheme is a partnership of more than twenty national organisations committed to promoting walking for health and the development of multi-use path networks in Scotland. The grant is a limited fund which has been made possible through support from Scottish Natural Heritage.

Grants of up to £1,500 are available for projects that improve, develop and promote paths in order to increase the use of these paths by local people. Projects must:

- Enable the improvement and development of local path networks, or will help improve links with a neighbouring community or amenity, such as a community hall, local allotments or parks.
- Enable the design and/or print of new path promotional materials.
- Demonstrate evidence of need for local path improvement or development.
- Encourage local volunteers to carry out improvement or development work on local paths.
- Encourage more people to use local paths in their communities.

- Be able to show the success of the path improvement or development through appropriate monitoring and evaluation.

Please note that In kind contributions must equate to the same value as the grant requested.

## Faith Organisations

### CINNAMON NETWORK – MICRO-GRANTS (SCOTLAND)

This scheme is working in partnership with the Peter Vardy Foundation and invites local churches in Scotland who want to start a recognised community franchise project to apply for a micro-grant to help with the initial costs of starting (not extending or providing ongoing support) a recognised community franchise project to meet a local need as well as to mobilise volunteers and receive regular financial support. Local churches or groups of churches working in partnership are eligible to apply.

## Miscellaneous

### COMIC RELIEF – INTERNATIONAL GRANTS PROGRAMME

This scheme is open to UK registered organisations including charitable incorporated organisations, community interest companies limited by guarantee, industrial and provident societies and housing associations to apply for Generating Ideas funding to carry out work in sub-Saharan Africa.

Generating ideas grants are usually for no more than six months and, in most cases, have a maximum value of £10,000. Grants are available for planning, consultation, putting together ideas or testing something on a small, pilot basis.

Applicants can select up to three of the following goals for each application submitted:

- Women aged 15 to 49 years and children under five have improved health.
- Disadvantaged children and adults gain access to, and attain, a good quality of education.
- Women and girls are equal and respected members of society.
- Slum dwellers have an improved quality of life.
- Children and young people at risk are safer, with greater opportunities to increase their skills and life prospects.
- People affected by HIV have an improved quality of life.
- Poor people can improve their income through trade, enterprises and employment.

Funding is available for work that will contribute to the following outcomes:

- Better Futures – enabling some of the world's poorest people to gain access to vital services such as health and education.
- Healthier finances – tackling financial poverty and enabling economic resilience in families and communities, as well as supporting enterprise and employment.
- Safer lives – reducing violence, abuse and exploitation.
- Stronger communities – empowering people, organisations and networks to play an effective role in their communities and society, as well as nurturing talent and leadership.
- Fairer society – helping people overcome inequality and have a say in decisions that affect their lives, whoever and wherever they are.

### JOHN ELLERMAN FOUNDATION

This scheme aims to advance the wellbeing of people, society and the natural world. Support is available for charitable work in the arts, environment and welfare. The Foundation is keenly aware of the connections between these areas and their effects on each other and on people's health and happiness.

The Foundation normally supports core funding for two or three years, but will also consider projects. The minimum grant available is £10,000 with maximum grant set, but grants over £100,000 are unusual. Grants can also be used as matched funding.

Please note the Foundation does not consider applications from organisations that:

- Have applied unsuccessfully within the previous 12 months.
- Have had a grant which ended less than 12 months ago.
- Focus on a single medical area, such as an individual disease, organ or condition.
- Are hospitals, hospices, schools, colleges or universities, unless the application is from a leading university specialist unit.

## Sport

### 2014 COMMUNITIES

This scheme provides financial assistance is available to encourage more people in Scotland to take part or volunteer in sport or physical activity, as well as encourage greater community cohesion in the run-up to the Glasgow 2014 Commonwealth Games and beyond.

# Trusts

- Organisations must have a constitution and a bank account.
- The Trust's focus is on funding smaller forward-looking groups that are led by capable and committed people.

Organisations that have previously been refused funding by the Trust should not reapply until at least 12 months after the date of the refusal letter.
