## News

### PROGRAMME NEWS

#### TRANSPORT SCOTLAND'S PRE-APPLICATION SUPPORT FUND (PASF) IS NOW OPEN FOR APPLICATIONS

This fund is offering funding of up to £10,000 to help public, community and third sector organisations develop ideas for the European Regional Development Fund (ERDF) Low Carbon Travel and Transport (LCTT) Challenge Fund.

The LCTT Challenge Fund is expected to go live in November/December 2016 and will provide **capital funding** to support the development of 'hubs' which focus on *active travel* or *low carbon* transport (and associated path networks) or which offer an integrated approach to both.

- **Active Travel Hubs** will provide focal points for cycling and walking routes. The specifics of each Hub will be tailored to the location and based on need, but will typically include bike library initiatives/bike hire, safe and secure facilities for personal bikes, bike repair/maintenance facilities, improved links to public transport, local path networks, travel information and associated outreach activity.
- **Low Carbon Transport** hubs will provide refuelling facilities for a range of alternative fuels and transport modes. We envisage that the locations and composition of these hubs will be determined by local circumstances and demand but typically are likely to include a mixture of low carbon vehicle refuelling infrastructure, such as electric vehicle charging points, hydrogen refuelling stations and gas refuelling facilities.

To assist organisations in developing strong bids for the LCTT Challenge Fund, this fund can provide eligible organisations with **up to £10,000** to support a range of development activity, such as:

- ✓ Scoping or feasibility studies
- ✓ Business plan development
- ✓ Technical report and scheme design studies
- ✓ Community engagement
- ✓ Identifying sources of eligible match funding
- ✓ Identifying suitable sites for hubs, including landowner engagement
- ✓ Investigating links with existing active travel infrastructure and provision
- ✓ Advice on technical specifications for low carbon vehicle hubs e.g. power supply required or source of alternative fuels
- ✓ Identifying research and data sources
- ✓ Establishing baseline evidence

Detailed guidance on PASF, including eligibility criteria and an application form are available here. **The deadline** for submission of PASF applications is midnight, **17 August 2016**, and expect to notify applicants during the week beginning 5 September 2016.

### CELEBRATE SCOTLAND

On 6 July 2016, Celebrate Scotland opened. This is funding between £500 and £5,000 to celebrate a community's history, or to bring people together.

Applications will be assessed on a first come first served basis until all funding has been awarded. The organisation have £575,000 available. Please note that Celebrate Scotland is different from Celebrate that ran in 2013/14 as part of the Commonwealth Games.

### COASTAL COMMUNITIES FUND

On 4 July 2016, round 4 of Coastal Communities Fund opened to eligible coastal local authority areas. Page 5 of the guidance notes confirms the eligible areas. Funding can go between £50,000 and £300,000.

### THE ROBERTSON TRUST

The Robertson Trust has now published its **Giving Strategy 2016-2019** which can be accessed by following this link.

The document sets out the Trust's future priorities when awarding funds through to their open grants programme and describes their three newly-developed funding strands:

- Care and Wellbeing
- Strengthening Communities
- Realising Potential

The strategy went live on **Monday August 1**, at which time the online application form and guidelines were refreshed to reflect the changes.

### BIG LOTTERY LAUNCH NEW COMMUNITY ASSETS PROGRAMME

This scheme aims to empower people to create strong and resilient communities by helping them to acquire, manage or develop assets such as buildings or land.

They also want to fund work that is people-led, strengths-based and connected. Further information about understanding these 'three approaches' is available, including case studies.

They've found that talking with applicants earlier in the process can lead to stronger applications. Because of this, there is no application form. The first step is to talk to them about your idea so they can give you advice on whether or not this funding is right for what you want to do. If they think your idea potentially fits with Community Assets they will then normally arrange to visit you.

Through Community Assets they are looking for strong applications which:

- Are rooted in the community, are genuinely community-led and give the community a stake in local decision-making
- Are connected to other organisations and services in the community
- Show clearly the changes that will take place and why this is the best way to deliver these changes
- Show the developments will be economically sustainable once our grant has ended.

They want to focus their funding where it will have the most impact so will prioritise applications that address disadvantage and inequality. Some real-life examples, can be found on their blog at <https://bigblogscotland.org.uk/category/community-assets-case-studies/>

You can apply if your organisation is community-led, has open membership, and a social purpose. Your organisation must have a governing body such as a committee or board. Your governing body must have at least three unrelated people on it and a written governing document, for example, a constitution. The governing document should be clear that the organisation has:

- A social purpose – the organisation must have a clearly stated purpose which benefits your local area in some way
- Open membership – everyone living in your area should be able to get involved in your organisation and the work that it does
- Community control – the majority of people serving on your governing body should be from the local area and make the decisions

If your organisation doesn't meet the above criteria but you feel it is representative of the people in your area they are still interested in hearing from you.

Please note that they can't accept applications from one organisation applying on behalf of another. Existing Big Lottery Fund grant holders can apply but you can only have one Community Assets grant at a time.

They want to provide longer term funding that offers community-led organisations stability to deliver great work, so you can apply for up to five years funding. You can apply for capital funding (such as building or refurbishment costs), revenue funding (such as salaries and running costs) and the cost of acquiring an asset.

Although they encourage match-funding in applications, they can fund up to 100 per cent of activity costs including staff, training, volunteer expenses, equipment, premises costs, evaluation and overheads.

## BAIRDWATSON CHARITABLE TRUST – IMPENDING DEADLINE

This scheme makes grants for charitable work related to getting unemployed people into work, employment programmes, social enterprise, supported employment, employment training for young people, or vocational skills. It has a particular interest in Ayrshire, and North Lanarkshire.

The trust has a grants programme of around £80,000 per annum and meets 3 times a year. The next meeting of trustees will be in September 2016. Grants are usually between £3,000 and £15,000 a year and funding may be for up to 3 years.

## SOUTH AYRSHIRE CHARITABLE TRUST

### Applications now open

The South Ayrshire Charitable Trust has been set up to assist and improve the lives of South Ayrshire residents who are in need because of poverty, age, ill-health, disability, financial hardship or other disadvantage.

What funding is available?

The South Ayrshire Charitable Trust has almost £760,000 of funding available to help tackle poverty and assist those in need. The funds are split geographically:

- Ayr – £563,500
- Barr – £500
- Girvan – £50,000
- Coylton – £7,000
- Maybole – £3,395
- Prestwick & Monkton – £126,000
- Troon – £9,500

Please note:

There is maximum award of £10,000 for applications to the Ayr, Prestwick & Monkton fund. A limit of £5,000 is in place for applications from Girvan. The maximum amounts will be reviewed annually by the trustees who oversee the fund.

### Who can apply for funding?

Funding is available to groups, organisations and individuals provided they can demonstrate to trustees that the funding will be used to help those in need living in South Ayrshire.

Possible activities the trust may support could include, but are not limited to:

- Providing grants to local clubs or organisations which support the poor, the disadvantaged, the disabled, the elderly or the sick
- Providing grants to purchase items for projects that will benefit local residents and patients of hospitals and care homes

### How do I apply?

There is a group application form and an individual application form for each geographical area. Applicants will be required to show that the funding will be used for the benefit of the residents of the specific geographical area.

## Information

### COMMUNITY SHARES SCOTLAND

Crowdfunding offers both commercial and non-commercial ventures the opportunity to raise a sum of money by offering shares to people who put forward small amounts of money. Community Shares Scotland connects not-for-profit groups and investors looking to provide money for social good. People buying shares in the projects promoted through the site will recoup their investment through improvements to their community rather than profit. Social businesses can offer interest to be paid on the shares if the profit from trading is sufficient.

Community Shares Scotland hopes it can provide organisations such as community groups looking to save a local shop or start a local food scheme with access to funds.

The programme is scheduled to run for three years and its partners include the Plunkett Foundation, Co-ops UK and Rocket Science. It is funded by the Big Lottery Fund and Carnegie UK Trust through an award of £800,000.

A series of Community Shares Scotland road shows will take place across Scotland providing local groups with more information about how to get involved. Although dates have not been released yet, information will be available from their website when they are.

### PEER-TO-PEER MENTORING SCHEME /INSPIRING STUDY VISIT SCHEME

The Plunkett Foundation have secured funds from the Prince's Countryside Fund to deliver a Peer-to-Peer mentoring scheme and an Inspiring Study Visit scheme for Scotland.

### RESOURCE EFFICIENT SCOTLAND

This scheme is a Scottish Government funded programme delivered by Zero Waste Scotland. It works to engage Scottish business, the public sector including local authorities and housing associations and third sector organisations on the benefits of using resources more efficiently and to help them implement resource efficiency actions within their organisation.

There are three main elements to the programme:

### 1. Advice and support service:

(Tel: 0808 808 2268) this service provides free advice, support, training and access to funding to help organisations implement resource efficiency measures.

### 2. Sector Programmes:

These programmes provide a strategic sector focused approach with activities tailored around specific resource-use 'hotspots'.

### 3. Innovation:

This area of work involves the development of new resource efficient products and technologies, business models, working practices and de-centralised renewable energy infrastructure – providing solutions for the sector support and advice services.

# New Funding Opportunities

## Arts, Culture & Heritage

### HISTORIC SCOTLAND – HISTORIC BUILDING REPAIR GRANTS SCHEME

This scheme provides funding for the repair and conservation of historic buildings in Scotland assessed as being of outstanding architectural or historic interest.

Grants, up to £500,000 are awarded primarily for urgent repairs that need to be done within two years to prevent loss or damage to important historic fabric.

Owners must insure and maintain the building and allow some access to the public in return for financial help.

You must be legally responsible for the repair of a historic building to apply for a Building Repair Grant.

Individuals and organisations (public and private) may apply for a Building Repair Grant. This includes:

- Private homeowners
- Trusts
- Commercial enterprises
- Local authorities

Applicants must have legal responsibility for the repair of a historic building and must usually either:

- Own the building; or
- Hold a full repairing lease, which has at least 21 years to run

Applications for Building Repair Grants throughout the year are accepted throughout the year and are considered in three batches. Applications should be made through their Grants Online Portal. New users must register with the portal first.

### MICHAEL TIPPETT MUSICAL FOUNDATION

This scheme makes grants available for the development of group music-making in the UK, especially involving young people in projects incorporating composition and creative ideas.

This is a small foundation with funds from the royalties generated by performances, broadcasts and publication of the works of composer Michael Tippett (1905-98). When he set up the Foundation, Tippett said he wanted the funds to go towards young musicians and composers, not towards promoting his own works.

Applications for grants ranging between £500 – £4,000 should include a short introductory letter (maximum one page of A4) clearly identifying the organisation and individual/s applying, the sum requested, the names and contact details of two referees willing to support the application; and a Project Description (maximum two single-sided A4 pages) for presentation to trustees, covering the following areas:

- **Title:** Organisation applying, project title and sum requested
- **Musical aspirations, aims, content and intended outcomes** – see points above
- **Numbers and ages of participants** with names of schools or other organisations which will benefit/participate in the project and a plan for recruitment if not working with pre-existing groups
- **The artistic leadership of the project** – named and with experience detailed
- **Project plan** including the start date, time frame, number of sessions and where it will take place
- **The management of the project** and plans for evaluation
- **The project budget**, preferably on a single page, showing estimated expenditure and anticipated income from all sources, including grants and applications to other bodies, with explanatory notes if needed. The trustees understand that a grant from the Tippett Foundation may be only one of a number of different funding sources.

Applicants are asked to note that overlong applications will be cut and the trust cannot fund instruments, equipment, recordings, individual study costs, retrospective applications.

## Children & Young People

### GANNOCHY TRUST

This scheme makes grants available across Scotland for work that aims to inspire young people under 25 years of age, and for projects in Perth and Kinross that aim to improve the quality of life for local people.

The Gannochy Trust was founded in 1937 by Arthur Kinmond Bell, whisky distiller of Perth, who built the Gannochy Housing Estate in Perth consisting of 150 houses which was completed in 1932. This model scheme was a significant element in the foundation of the Trust.

After undertaking a review of its grant making procedure, the Gannochy Trust has decided to focus on two priority areas for 2015-18. These are:

- Inspiring young people
- Improving the quality of life of the disadvantaged and vulnerable

The following levels of funding exist:

- **Both funding streams:**
  - Small grants of up to £10,000 per annum or £25,000 over three years. The average grant is £5,000 per annum
  - Main grants of up to £30,000 per annum or £75,000 over three years. The average grant is £15,000 per annum
- **For Perth and Kinross only:**
  - Major grants of over £30,000 per annum up to a maximum of £120,000 over three years. The average grant is £40,000 per annum
  - Capital grants with no limit

As a general rule, the trust will not make donations which, for revenue grants, exceed 50% of the salary costs of one member of staff or 50% of project costs.

For capital costs, the trust expects applicants to have at least 40% of project costs secured before submitting an application. The trust will normally fund 10-25% of the cost.

Organisations recognised by the Office of the Scottish Charity Regulator (OSCR) may apply. Community groups and village halls that are not registered charities should contact the Trust prior to applying.

Only one application per charity will be considered in any 12-month period. Applications must be specific and preferably for a project with a defined outcome, not general running costs. Applications will seldom be considered for more than a three-year commitment.

The trust has identified two priority areas it wishes to focus on for 2015-2018:

- **Theme 1:** Inspiring Young People (Scotland wide) – including projects working with young people under 25 which:
  - Create positive change in the lives of young people
  - Raise aspirations and help to realise full potential
  - Develop talent
  - Enhance social, personal and leadership skills
  - Develop training, skills and knowledge to increase employability
  - Encourage and develop young leaders
  - Increase participation as active citizens

Applications under this theme should have a strong focus on supporting and empowering young people in communities that are experiencing economic or social disadvantage.

- **Theme 2: Improving the Quality of Life of People** (currently restricted to projects taking place in Perth and Kinross) – including projects which:
  - Support the disadvantaged and the vulnerable
  - Increase the availability or quality of facilities for wide community use
  - Make Perth and Kinross a better place to live and work

## Disabled

### ACT FOUNDATION (ACT)

This scheme provides grants to individuals and other charities, principally in the UK, with the aim of enhancing the quality of life for people in need, specifically the mentally and physically disabled and the aged.

To be eligible charities should have registered for at least three years; funding is at the discretion of the trustees with no upper limit on awards. Previous grants have been for between £100 and £4 million. Grants generally fall into the following areas:

- Building – funding modifications to homes (where a Disabled Facilities Grant) has already been awarded), charities, special schools, hospices
- Equipment – provision of specialised wheelchairs, other mobility aids and equipment including medical equipment to assist independent living.
- Financial assistance – towards the cost of short-term respite breaks at a registered respite centre

Charities and Overseas Charitable Organisations must submit a letter on the organisation's headed paper and should:

- Give a brief description of the organisation including any statutory or voluntary registration
- Provide a summary of the work the organisation plans to undertake with the grant, together with a cost breakdown, plans and/or specification if available and a summary of the key milestones for the work
- Provide information on why the organisation needs to do this work and what would happen if not able to do it
- Give details of any other UK-based support received or pledged for the project
- Specify what the organisation expects the results of the work to be and the number of beneficiaries helped
- How the organisation plans to evaluate whether the work achieved its goals
- Detail if the work will require capital and/or ongoing operational funding and if so how the organisation plans to meet these costs

Applicants must attach the following financial information to the letter:

- A cashflow projection of income and expenditure budget for the work
- Details of any income already raised for the work and income outstanding and where the organisation plans to raise it from

- The organisation's latest annual report and accounts

Successful applicants must keep a financial record of the spending of the grant and retain a copy of any appropriate invoices and receipts, and submit these to ACT if requested.

The support of ACT must be acknowledged in all publications concerning the project as well as in presentations (oral or written) and interviews.

## Environment

### **PATHS FOR ALL (SCOTLAND) HEALTH WALK GRANTS**

This scheme comes from the Scottish Government and is managed by the Paths for All Partnership. The funding is for initiatives in Scotland that increase the health and well-being of less active people by promoting regular walking to work, school or the shops.

As well as investing in community projects which build local capacity and improve physical health levels, the grants are aimed at businesses who wish to implement a workplace walking initiative to improve their employees' health.

There are two levels of grants available:

- Small grants of up to £5,000
- Large grants of up to £30,000 (maximum of £20,000 for organisations that have already received a grant)

Only constituted groups and organisations based in Scotland are eligible to apply, and the work which the grant will support must be carried out in Scotland.

Applications will be accepted from workplaces, voluntary and community organisations, registered charities, public sector bodies and private sector organisations as long as they can show that their project will benefit inactive people.

Projects should meet all of the following objectives:

- Deliver volunteer led health walks in communities
- Demonstrate evidence of local need
- Work in partnership to increase reach involving local and/or national partners
- Contribute to organisational outcomes
- Demonstrate competency in project management
- Have considered how the project will show success through monitoring and evaluation

Large grant applicants that are considering applying for the maximum grant should plan for a project delivering across at least two years which involves a dedicated post which would promote walking.

Grants may be used to cover staff salaries, running costs of projects, materials, training and volunteer expenses.

Applications for funding to support the continuation of existing projects may be considered, if applicants are able to demonstrate the current achievements of the project and the impact that the funding will have on continued development and sustainability.

## Miscellaneous

### ALLEN LANE FOUNDATION

This scheme makes grants available to small registered charities, voluntary groups and charitable organisations in the UK for work that makes a difference to people's lives as opposed to simply alleviating the symptoms or current problems and should aim to reduce isolation, stigma and discrimination.

The Allen Lane Foundation is a grant-making trust and was set up in 1966 by the late Sir Allen Lane, founder of Penguin Books, to support general charitable causes. The foundation has no connection with the publishing company, but five of the trustees are members of the founder's family.

One-off grants of between £500 and £15,000 are available. The average grant is between £5,000 and £6,000.

Grants repeated for more than one year vary from around £500 per annum up to £5,000 per annum, for a maximum of three years.

Registered charities are eligible to apply as well as other organisations which are not charities, but which seek funding for a charitable project.

To make sure its grants have an impact, the foundation will not fund larger organisations. If an organisation works in a relatively local area – a village, or estate or small town – to be eligible it will have an income of less than about £100,000. At the other end of the spectrum, an organisation which works across the whole of the UK will be eligible if it has an income of not more than about £250,000.

The foundation makes grants for work all over the United Kingdom but not where the beneficiaries of the work all live in London. Organisations which have their offices in London would still be eligible provided the people who benefit from their work are not only in London.

The foundation will not normally make grants to organisations which receive funding (directly or indirectly) from commercial sources where conflicts of interest for the organisation and its work are likely to arise.

It aims to help organisations to become sustainable. The funding will support running and core costs to enable them to have flexibility, security and longevity.

Eligible work must benefit adults from the following groups, or generalist work which includes significant numbers from more than one such group:

- Asylum seekers and refugees (but not groups working with a single nationality)
- Gay, lesbian, bi-sexual or transgender people
- Gypsies and Travellers
- Migrant communities
- Offenders and ex-offenders
- Older people
- People experiencing mental health problems
- People experiencing violence or abuse

The following types of activities are eligible for support:

- Provision of advice or information
- Advocacy
- Arts activities where the primary purpose is therapeutic or social
- Befriending or mentoring
- Mediation or conflict resolution
- Practical work, such as gardening or recycling, which benefits both the provider and the recipient
- Self-help groups
- Social activities or drop-in centres
- Strengthening the rights of particular groups and enabling their views and experiences to be heard by policy-makers
- Research and education aimed at changing public attitudes or policy
- Work aimed at combating stigma or discrimination
- Work developing practical alternatives to violence

Grants may be used for start-up, core or project costs, for example:

- Volunteers' or participants' expenses
- Venue hire

- Part-time or sessional staffing costs
- Work aimed at strengthening the organisation such as trustee or staff training

The foundation is particularly interested in unusual, imaginative or pioneering projects which have perhaps not yet caught the public imagination. If an applicant has any queries about making an application, they are advised to contact the foundation direct. Applications should be sent to the Foundation's office where processing an application tends to take between two and six months.

While there is no formal application form; requests should include a completed registration form (available from the foundation's website). An application should be no more than four sides of A4 and should be accompanied by the budget for the work, plus a copy of the budget for the whole organisation, the organisation's latest annual report and accounts.

## Social Enterprise

### ASDA COMMUNITY CAPITAL FUND

Applicants should be able to show how taking on this loan investment will enable them to become more financially sustainable after the investment has been paid back.

Around 10-20 organisations per year will be chosen to receive funding. Candidates should be able to show that their enterprise would benefit significantly from this loan investment which is intended for the purposes of innovation, asset purchases/ improvements and for growing the organisation.

## EUROPEAN MOBILITY WEEK AWARD

- The innovativeness of the permanent measure(s) implemented on the occasion of the Week, regarding its/their public awareness-raising impact and its/their effectiveness in terms of sustainable mobility
- The quality and scope of the partnerships with local stakeholders for organising the European Mobility Week

The theme is 2016 is 'Smart and sustainable mobility – an investment for Europe'. The theme invites people to reflect on mobility habits and to consider the positive economic impact that smart and sustainable transport modes can have on households, the economic actors in cities, and society as a whole.

Local authorities wishing to participate in the Award must complete the application form in English, providing details about:

- Alternative transport modes and implemented permanent measures and nature
